AMICUS COMMENTARY TO MOTION FOR LEAVE (DOCUMENT 236) TO RESTRICT

COMES NOW Nancy Hitt, a seventy-six [76] year old woman concerned with the circumstances surrounding the Plaintiff Matthew Hale; I have read Document 236.

I learned of the Matthew Hale case through my contact with his Mother, Evelyn Hutcheson. I saw in Hale's case an example of matters that, sadly, have been with us as long as there has been "history." At one time, few people did not know the case of Alfred Dreyfus, a French soldier wrongly convicted of treason when his only crime was being despised and rejected because he was a Jew. The same can be said of Matt Hale. He is despised and rejected because he holds viewpoints that are despised and rejected by the very society that has used fraud and lies to punish him for imaginary crimes.

Today, our newspapers are filled with stories about "gangs." 
