AMICUS CURIAE COMMENTARY TO THE DEFENDANT BOP'S REQUEST TO  
RESTRICT ACCESS TO DOCKET ENTRY 234 (DOCUMENT 236).

The Plaintiff Rev. Matthew Hale, doesn't lose his First Amendment Rights- just because he is locked up in a Building, specifically a Building that us Tax Payers are Funding. That said, it stands to reasonably reason that us Tax Payers , Adherents to the Creativity Religion have a Public interest in maintaining our First Amendment Right to share our common Religious and Philosophical interests- with the Plaintiff Rev. Matthew Hale unimpeded by the Defendant BOP and the Defendant's Counsel Susan Prose.


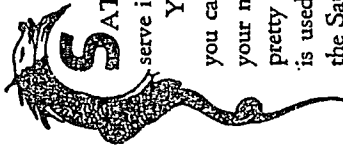

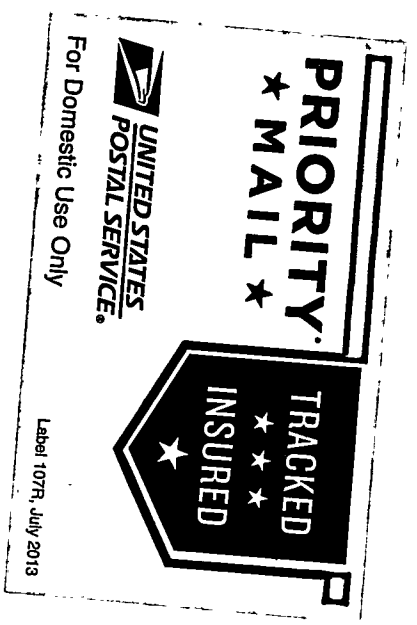
